The programme features contributions from leading scholars and practitioners from Belgium, the Netherlands, and the United Kingdom, and includes hands-on sessions

focused on developing a reference budget tailored to the Bulgarian context. Opportunities for networking, group collaboration, and mentoring are built into the agenda to foster peer learning and international exchange.

This summer school is particularly valuable for PhD students at the Business University of Varna and similar institutions, as it provides concrete tools to analyse income adequacy, poverty, and minimum living standards using real economic data from Bulgaria and other European countries. Participants will explore how reference budgets can support social policy design, inform financial education, and assess the affordability of essential goods and services in both national and comparative frameworks.

Through direct engagement with international experts and applied workshops, doctoral students will not only deepen their theoretical understanding, but also enhance their ability to conduct research with societal relevance and policy impact. The programme also serves as a gateway to broader European research networks in the fields of wellbeing, poverty, and inclusive growth.

Participants will leave with a deeper understanding of how reference budgets can be used to assess income adequacy, inform social policy, and contribute to the measurement of poverty, affordability, and social inclusion—key themes in both academic research and evidence-based policymaking.
